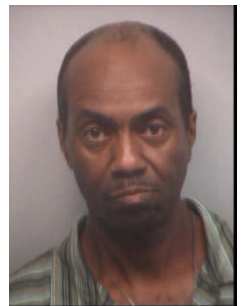

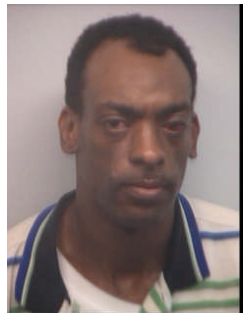
Robert King AKA James Lee, Kirby King (9/9/59)

- Case # to listed incidents **092242064, 081092378, 081811759, 082151098, 002722277, 012290976, 013112689, 051312176**



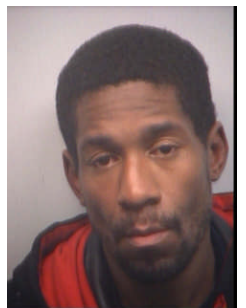
Demarco Presley (8/2/80)

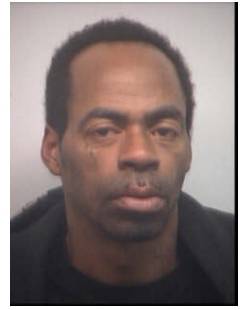
Michael Dash (11/9/70)

- Case # to listed incidents **080100847, 081801918, 082141473, 083000947, 091440101, 090331318**



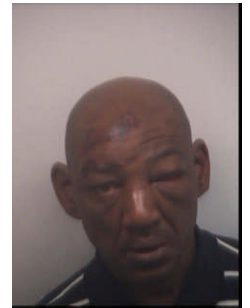
Tommy Steward (2/21/63)

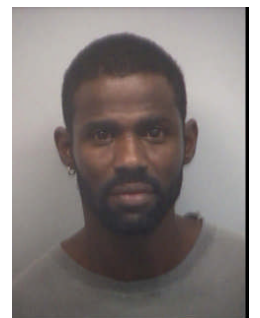
Dwight Beck (6/14/62)

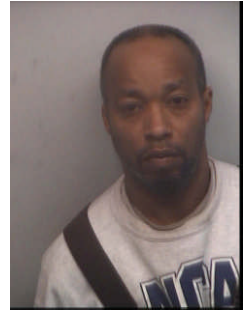
Cleveland Lamar (4/6/67)
