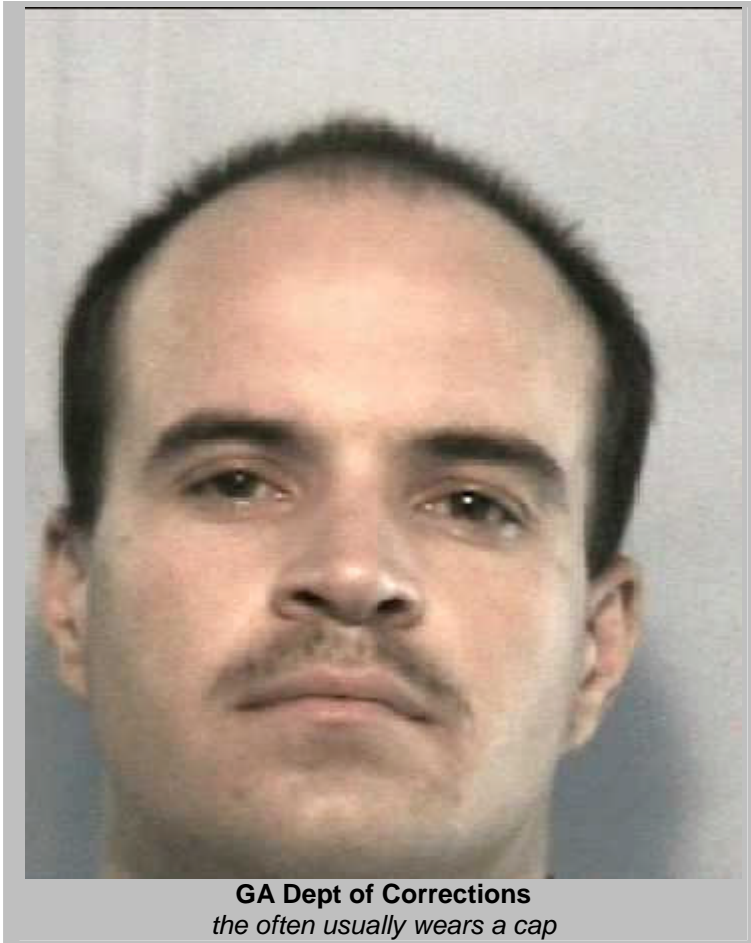

DRUG ARREST ON PONCE

In the early morning of 3/21/2010, two police officers arrested an individual frequently seen in the Ponce & Boulevard area on felony drug charges. As two APD officers watched street activity from the former Wachovia property, they spotted 32-year-old Andrew A. jaywalking across the street. The officers immediately intercepted him to cite him for violation of pedestrian duties, and in the process developed probable cause to search him and found methamphetamines.

The Fulton County Sheriff's office website later showed a booking for possession of Methamphetamines and a probation violation related to a previous conviction for Theft by stolen goods.

ANDREW ARNETT ACCEPTS PLEA DEAL (4/26/2010)

Andrew Arnett, who was arrested

in March for possession of methamphetamines on Ponce, accepted a very light sentence of five years probation. The prosecution recommended 10 years probation with banishment from Midtown, drug court treatment, and electronic monitoring. Despite his lengthy criminal history dating back many years, the judge only sentenced him to five years probation, and only banished from Ponce De Leon Avenue from West Peachtree to N Highland and one block around it. He is on intensive probation, and has a curfew set by probation.

Just on Friday, he was reported to have gotten off the Route 2 bus at the Ponce Kroger. We anticipate that he will appear frequently on Ponce, in defiance of his sentence. To better protect the Midtown community we will work out a protocol to deal with his blatant violation of his probation terms. Meanwhile, we have updated his profile sheet with new photos found on the web.

Background and research findings – This individual is seen frequently among the Ponce & Boulevard drug culture. He was recently convicted of theft by receiving, and is currently on probation for that case. Observant citizens have noted that he frequents some unidentified location near Charles Allen & 4th. Department of Corrections online records show felony convictions including Forgery in the First Degree, and two periods of incarceration.

We have requested that police and prosecutors keep us abreast on this case for court watch purposes, as part of our strategy to clean up the Ponce corridor.
